

#### **Sponsor/Vendor Contract**

ГhisAgreement is made on this date	_ between MID-MICHIGAN PET EXPO and
("Exhibitor"), with respect to the EXPO March 22-24, 2	2024 ("Event").

- 1. Permitted Activity. The Exhibitor is hereby permitted to sell or provide free samples of merchandise/services during there designated event times of the Event at their exhibit area designated by MID-MICHIGAN PET EXPO in exchange for Exhibitor's payment to MID-MICHIGAN PET EXPO in the amount set forth on this exhibitor confirmation. Exhibitor may begin setting up for the Event during their designated time on Friday, March 24 and must break down and remove its property not before tear down time on March 26 and no later than 11:59p on March 26 unless otherwise agreed upon by MID-MICHIGAN PET EXPO. In the event Exhibitor fails to remove property by the foregoing time, MID-MICHIGAN PET EXPO has the right to immediately remove and discard such property.
- 2. Payment. Payment for Sponsorship must be received in full upon signing of contract. For vendors only, 50% downpayment must be received with submission of your registration. The reminder must be paid in full prior to the agreed upon date to secure your discount fees. Deposits for your Exhibit Space are non-refundable if the Exhibitor fails to fulfill, violates, or cancels the Exhibit space.
- 3. Refunds: No refunds will be made if the Exhibit Space is unused or partially used. MID MICHIGAN PET EXPO does not guarantee financial gain to you or your organization, nor attendance at the Expo. If the Exhibitor gives notice to Show Management that the Exhibitor will not participate in the Expo and would like to cancel with more than sixty (60) days notice, Show Management will return 100% minus convenience fees. If the notice is received more than thirty (30) days, Show Management will return 50% of money received minus convenience fees. No refunds shall be given if the Exhibitor cancels less than thirty (30) days from the start of the MID MICHIGAN PET EXPO.
- 4. Cancellation. MID-MICHIGAN PET EXPO may cancel the event at any time. In the event of such a cancellation, any monies previously paid by the Exhibitor will be refunded and both parties will be relieved of any further obligations or liabilities in connection with this Agreement.
- 5. Insurance. Exhibitor will maintain in effect throughout the period of the Event Commercial Form General Liability Insurance, written on an occurrence basis with minimum limits as follows: Each Occurrence \$1,000,000; and General Aggregate \$1,000,000. The cop eraser referred to under this Section 3 shall include MID-MICHIGAN PET EXPO as an additional insured up to the minimum limited as stated herein. Exhibitor upon the execution of this agreement, shall furnish MID-MICHIGAN PET EXPO with certificates of insurance evidencing compliance with all requirements. In the event that the insurance is canceled or materially modified, Exhibitor agrees to give immediate notice to MID-MICHIGAN PET EXPO. MID-MICHIGAN PET EXPO shall not be liable or responsible for any loss, damage, or injury to any property owned, rented, leased, borrowed, or in the custody of the Exhibitor in or upon the Event priority, resulting from any cause whatsoever, including but no limited to theft and vandalism. Exhibitor shall be responsible for insuring its property, and the insurance covering such property shall contain a waiver of subrogation clause in favor of MID-MICHIGAN PET EXPO.
- 6. Indemnification. Exhibitor will indemnify and hold the MID-MICHIGAN PET EXPO its parent and affiliate companies and their respective officers, directors, employees and agents, harmless form and against all claims, losses, liabilities, damages and expenses (including attorney fees) on account of injury or death to any person, including employees of the parties hereto, or loss of or damage to property, arising out of any products sold by or on behalf of Exhibitor and any acts or omissions of Exhibitor or of its representatives.
- 7. Miscellaneous. This Agreement contains the entire understanding of the parties with respect to its subject matter, supersedes all previous oral or written representations. This Agreement may be modified or amended only by a written instrument executed by both parties. This Agreement will be construed in accordance with the laws of the State of Michigan; any action alleging a breach of this Agreement must be brought in the state or federal courts in Michigan, and the parties hereby consent to the jurisdiction of such courts.
