

# Pet Release

## Rules for pets:



*You must provide proof of vaccinations at the door upon check in. Dogs must be minimally 6 months old, free of aggression, and free internal and external parasites.*

*Non-retractable leashes only, retractable leashes are not permitted. You must clean up after your dog inside and outside. This form must be filled out and handed in at vaccination check.*

In consideration of being permitted to bring my pet to this Event (Mid Michigan Pet Expo), the signer of this document agrees to the following for each of the undersigned, including the signer him/herself, and his/her pet:

1. I agree to indemnify and hold harmless Mid Michigan Pet Expo, Dort Financial Event Center, United Dock Diving, United Flyball League International, Einstein Dog Training, including all owners, members, volunteers, and anyone associated with the organizations or the parent companies, and their representatives, from all claims, suits, expenses, damages, liabilities, and attorney fees or court costs as a result of my involvement in this Event.
2. I understand and acknowledge that attendance and participation in the Event is not without risk to me, or my dog. I agree that in the event of injury to my dog, or myself, I will agree to hold Mid Michigan Pet Expo, their employees, owners and officers, and all property owners of any affiliates whereas the Event is held, harmless from any loss, damage, or injury to any person, any animal, or any personal property, that may have arisen out of, or in any way connected in with the Event.
3. I assume all responsibility for any loss, damage, or injury done to myself, any personal property, other persons, or other dogs, by my dog's actions, or by me or my family, and that Mid Michigan Pet Expo reserves the right to determine if behavior exhibited by me, my family, or my dog, is inappropriate for the environment of the Event.
4. I understand if my dog is acting aggressively or out of control in any way that is considered hazardous to the environment, I will be asked to leave with no refund for entry.
5. My dog is free of aggression, not currently in heat, is free of internal and external parasites, and is up to date on all recommended vaccinations including rabies, distemper, and parvo.
6. I hereby release, waive, and agree not to sue Mid Michigan Pet Expo, its affiliates, facilities, facility owners or affiliates, sponsors, employees, promoters, venue representatives, dog owners, competitors, from all liability, for any reason.
7. I hereby assume all responsibility for any injury, death, or property damage, arising out of the Event for any reason, to me or as a result of me or my dog.
8. I agree to report any injuries to any person or animal to volunteers or representatives of the Mid Michigan Pet Expo immediately.
9. I will clean up after my pet, inside and outside of the facility.
10. Mid Michigan Pet Expo is not responsible for illness or injury that happens to me or my pet due to their participation in this event.

I have read this release and waiver of liability and assumption of risk, indemnity agreement, understand the terms, and understand that I am giving up substantial rights, including my right to sue Mid Michigan Pet Expo or its facilities, employees, officers, or affiliates. I am signing voluntarily, and release all liability to the greatest extent allowed by law. I agree to the terms of this contract are a complete and final agreement between myself and Mid Michigan Pet Expo.
